Disposal gain on vacant land

On 18 July 2011, the Group has made the announcement to Bursa Malaysia Securities Berhad on the disposal of a piece of vacant freehold industrial land held under HS(M) 25812, PT 72472, Tempat Sungai Balak, Pekan Kajang, Daerah Hulu Langat, Negeri Selangor measuring approximately 15,510 square metres. The said land was acquired on 15 August 1995

The gain on disposal on the said land was disclosed as part of the "gain on disposal property, plant and equipment" under Note 21 to the financial statements of Komarkcorp Berhad for the financial year ended 30 April 2012

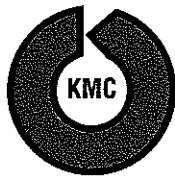
